Bylaws Updates as submitted by the Bylaws Committee on Monday March 26th, 2018

The following changes are recommended to be made to the WILLOW ROAD PTA bylaws:

In Article VI – Members and Dues

CURRENTLY READS:

Section 5. Each member of this PTA shall pay annual dues of **\$10** to the association. The amount of such annual dues shall include the portion payable to the state PTA to the National PTA.

RECOMMENDATION:

Section 5. Each member of this PTA shall pay annual dues of **\$12** to the association. The amount of such annual dues shall include the portion payable to the state PTA to the National PTA.

In Article VII – Officers and Their Election

CURRENTLY READS:

Section 2.

- a. The officers of the association shall consist of a president, or co-president, **1** vice president(s), **a recording secretary, a corresponding secretary, 2** council delegate and a treasurer.

RECOMMENDATION:

Section 2.

- a. The officers of the association shall consist of a president, or co-president, **2** vice presidents, **a secretary, 1** council delegate and a treasurer.

CURRENTLY READS:

C .Officers shall assume their official duties on July 1 and shall serve for a term **of two years** or until a successor is elected.

RECOMMENDATION:

C .Officers shall assume their official duties on July 1 and shall serve for a term **of one year** or until a successor is elected.

CURRENTLY READS:

Section 3.

- a. There shall be a nominating committee consisting of 5 members, 2 of whom shall be elected by the executive board from its body and 3 who shall not be members of the executive board.....its chair

RECOMMENDATION:

- a. There shall be a nominating committee consisting of 3 members, 1 of whom shall be elected by the executive board from its body and 2 who shall not be members of the executive board.....its chair.

In Article VIII – Duties of Officers

CURRENTLY READS:

Section 3. The Recording Secretary shall:

RECOMMENDATION:

Merge Section 3. and Section 4 for the SECRETARY position

In Article IX – Executive Committee

CURRENTLY READS:

Section 2. The executive board shall consist of the executive committee, chairmen of **standing** committees(or his/her designee).

RECOMMENDATION:

Section 2. The executive board shall consist of the executive committee, chairmen of **year-long** committees(or his/her designee).

CURRENTLY READS:

Section 5. The executive board shall meet **at least two (2)** times a year.....shall be given

RECOMMENDATION:

Section 5. The executive board shall meet **at least one (1)** time a year.....shall be given

In Article XI – Meetings of the Association

CURRENTLY READS:

Section 4. 20 members shall constitute a quorum.....of the association

RECOMMENDATION:

Section 4. 10 members shall constitute a quorum.....of the association

In Article XII – Committees

CURRENTLY READS:

Section 2.

- b. A person shall not be eligible to serve more than two consecutive years a chair of the same **standing** committee.

RECOMMENDATION:

Section 2.

- a. A person shall not be eligible to serve more than two consecutive years a chair of the same **year-long** committee

In Article XIII – Council Membership

CURRENTLY READS:

Section 1. The association shall be represented at meetings of the District #13 Interschool Council of PTA of Parent Teacher Associations by the president/alternate and by **2 council delegates** as determined by the bylaws.

RECOMMENDATION:

Section 1. The association shall be represented at meetings of the District #13 Interschool Council of PTA of Parent Teacher Associations by the president/alternate and by **1 council delegates** as determined by the bylaws.
